**Guidelines for Admission in 5+1 years Pharm. D Course**  
**Academic Year 2021-22**

**1) Admissions in 5+1 Year Pharm. D. course shall be given as under;**

- a) 50% of total approved seats of each GTU-affiliated institute shall be filled on the basis of merit list prepared by GTU- Pharm D. Admission Committee.
- b) Management Quota Seats (50% of total approved seats of each institution, including fifteen percent (15%) Non-Resident Indian (NRI) seats) shall be filled by the Management of the respective Educational College / Institution, on the basis of inter-se merit list of the students.
- c) Admission to Pharm D course will be carried out as per the PCI norms.

[Note: If the management of GTU affiliated institute has surrendered management quota seats to GTU, the same will be filled by the GTU on the basis of the merit list prepared by the GTU]

**2) The admissions for 50 % Seats of GTU quota for this course shall be done in the following manner.**

- a) 80% of seats : For 10+2 passed students of Gujarat with Physics and Chemistry as compulsory subjects along with Mathematics or Biology
- b) 10% of seats : For D. Pharm. Students and
- c) 10% of seats : For the students of other states of India

In case of non-availability of students from (a), remaining seats in (a) may be allotted to the students from (b) & (c) on equal basis. Similarly in case of non-availability of students from (b) remaining seats in (b) may be allotted to students from (a) & (c). Similarly in case of non-availability of students from (c) remaining seats in (c) may be allotted to students from (a) & (b).

**3) Eligibility for Admission:**

Candidate desirous to get admission in the first year of Pharm. D. course:

**Students of Gujarat State should have passed following examinations:**

- (i) 10 + 2 examinations with Physics and Chemistry as compulsory subjects along with one of the following subjects: Mathematics or Biology from schools located in Gujarat and affiliated to Gujarat Board or CBSE or ICSE or International School Board or National Institute of Open Schooling.

**OR**

**Students from other states of India Should have passed following examinations:**

- (i) 10 + 2 examinations with Physics and Chemistry as compulsory subjects along with one of the following subjects: Mathematics or Biology from schools affiliated to state Board or CBSE or ICSE or International School Board or National Institute of Open Schooling.

**OR**

(ii) A pass in Diploma Pharmacy Course from an institute located in Gujarat and approved by Pharmacy Council of India under section 12 of the Pharmacy Act.

**OR**

(iii) Any other qualification approved by Pharmacy Council of India as equivalent to any one of the above examination.

#### **4) Reservation of Seats**

a) For the purpose of admission, the seats shall be reserved for the candidates who are of Gujarat origin and falling under the following categories and in following proportion, namely;

- (As per PCI these are supernumerary seats, so cannot be converted if they remain vacant)

- b) A candidate seeking admission on reserved seat shall be required to produce a Certificate of Caste/ Income Certificate authorized by the competent authority. Provided that the candidate belonging to SEBC shall be required to produce a certificate to the effect of non-inclusion in Creamy Layer in addition to the caste certificate. Certificate should be valid for three years from the date of issue.
- c) As per the resolution of State Government (No. EWS/122019/45903/A dated 26/06/2020), the validity of EWS Certificate issued from 25/01/2019 to 12/09/2019 is extended for 3 years. To avail the benefit of extended validity of EWS certificate (issued from 25/01/2019 to 12/09/2019), the candidate is required to give undertaking to the Admission Committee that there is no increase in the family income and they are eligible as per the criteria decided by state government for availing the benefit of reservation. (As per Annexure 1)
- d) No caste certificate shall be valid unless it is duly stamped, signed and issued by the authority empowered by the Government of Gujarat.
- e) No certificate to the effect of non-inclusion in Creamy Layer shall be valid, unless it is duly stamped, signed and issued by the authority empowered by the Government of Gujarat. Certificate should be valid for three years from the date of issue.
- f) If a candidate of reserved category gets admission on unreserved seat in order of merits, he/she may be given admission on the unreserved seat according to his/her Preference and merit.

- g) The admission of a candidate from a reserved category on a reserved seat shall be valid subject to the verification of caste certificate issued to him/her by the authority empowered by the State Government in this behalf. In case the caste certificate is found to be invalid on verification, he/she shall not have right to claim his/her admission on a reserved seat and if he/she has already been granted admission, such admission shall be cancelled. Admission of such candidate may be continued in case of availability of vacant unreserved seats, subject to the condition of eligibility of merit.
- h) After granting admission to all the candidates of reserved categories on respective reserved seats, the reserved category seats remaining vacant shall be transferred to the other category as per Government of Gujarat norms.

#### **5) Reservation for Physically Disabled Candidates:**

Five percent (5%) of the available seats in each category shall be reserved, in accordance with the provisions of the section 32 of the rights of persons with Disabilities ACT, 2016 (49 of 2016) for the persons with benchmark disability who can perform the academic activities in the respective course. A candidate with disability shall have to submit certificate of disability issued and duly signed by the certifying authority.

**Explanation:** “person with disability” means a person suffering from not less than forty per cent (40%) of any disability as certified by a competent medical authority.

#### **6) Reservation for the Children of Defense Personals and Ex-Servicemen**

- a) One percent (1%) of available seats shall be reserved for the children of Defense personnel and Ex-Servicemen, for admission.
- b) A candidate claiming admission against Ex-Servicemen category shall be required to submit a certificate to that effect duly issued by the Director, Sainik Welfare Board, Gujarat State or by the District Sainik Welfare Officer. In-Service Defense personnel shall be required to submit certificate to that effect duly issued by the Commanding Officer of the respective unit in which they are serving.
- c) The seats remaining vacant against the category of Defense Personnel and Ex-Servicemen shall be filled up from the merit list of unreserved category candidates.
- d) The admission on such reserved seat shall be valid subject to the veracity of the certificate being confirmed by the authority by whom the certificate is issued.

#### **7) Registration for Admission:**

- a) The GTU- Pharm D. Admission Committee, by advertisement in the prominent newspaper/s widely circulated in the State, by web-site and by such other means, as the Committee may consider convenient; publish the date of registration, last date of registration etc., and such other information as may be necessary in this behalf.
- b) To get admission, a candidate shall fill-up the online form from the website i.e. <http://www.admission.gtu.ac.in/> within the given time period.
- c) A candidate has to upload the self-attested copies of requisite certificates and testimonies as specified in the application form.
- d) A candidate shall require to make payment of Rs. 500/- (Rupees Five hundred only) nonrefundable towards registration fees to be paid online through the GTU-Online SBI Portal and make payment **under “Admission Form Fee” with remark as Pharm.D.** The details are available on the link: <http://gtu.ac.in/ImpCircular/SBIPayment%20Instructions.pdf>

- e) An acknowledgement receipt of the fees paid for the same shall be generated online. It is required to upload this payment receipt in admission form.
- f) Where a candidate has made more than one registration, the registration made at the latest stage shall be taken into consideration and the other registration shall be treated as cancelled.

### 8) Preparation of Merit List

- a) The merit list of the candidates, who have got their names registered under sub-rule 7(B) and who are found eligible for admission under these rules, shall be prepared by the GTU- Pharm D. Admission Committee.  
The merit list shall be prepared with fifty percent (50%) weightage of the percentile marks obtained in the theory subjects (Physics, Chemistry and Biology or Mathematics) combined with fifty percent (50%) weightage of the percentile marks obtained in the GUJCET exam with the same subjects in the corresponding year.
- b) The merit list for students of diploma in pharmacy will be prepared on the basis of their CGPA score.
- c) The merit list for students who have passed standard 12 examination from outside Gujarat (**Other states**) will be prepared on the basis of All India Rank of NEET or JEE (Mains) examination or percentile rank of GUJCET examination for the corresponding year. In case a candidate has appeared at more than one of these exams than the higher rank among these examinations will be considered for deciding the merit.
- d) The criteria for deciding merit order in case of candidates having equal merit marks shall be based on the percentage or percentile marks obtained in the qualifying examination in following sequence, namely (theory only)
  - i. Mathematics/ Biology and Chemistry
  - ii. Mathematics/ Biology and Physics
  - iii. Physics and Chemistry
  - iv. Mathematics / Biology
  - v. Chemistry
  - vi. Physics
  - vii. English
  - viii. Aggregate marks**Note:** - For the diploma students having equal merit order, the GTU convocation norms of tie breakers will be applicable.
- e) The percentile marks shall mean only the percentile and while preparing the merit list, the percentage obtained by the candidate shall not be taken in to account. However, only for the purpose of deciding the merit order of candidates having equal merit marks, the percentage of marks shall be considered as stated in para (D) above.

**9) Admission Procedure:** The GTU- Pharm D. Admission Committee shall prepare a merit list of eligible candidates, who are registered under sub-rule 7(b) subject to the verification of the documents submitted under sub-rule 7(c).

- a) The merit list shall be displayed on the GTU admission portal [www.admissions.gtu.ac.in](http://www.admissions.gtu.ac.in).
- b) Students are required to do choice filling online through GTU admission portal for selection of Institute/College based on their preference.
- c) Allotment of seats shall be made on the basis of merit, category of the candidates and availability of seats.

- d) Students are required to report at the allotted institute for confirmation of admission and payment of the token fees of Rs.25000 within 3 days. Remaining fees for first term should be paid within a week at the institute.
- e) The seat will be treated as cancelled if the fees for the first term is not paid by the student in the allotted time.
- f) In case the seats remain vacant after the completion of first round of admission process, such vacant seats will be displayed on the official website.
- g) For the second round, students are required to fill the choice online through GTU admission portal for selection of Institute/College based on their preference.

#### **10) Fees:**

- a) A candidate who gets admission shall have to pay such fees, as may be determined/ approved/ finalized by Gujarat Technological University for the concerned institute.
- b) In case the candidate who has paid the fees after getting admission and gets his/her admission Cancelled, provided that the seat vacated by him/her is filled by another candidate, shall be paid back the fees paid by him/her after the completion of admission process after a deduction of Rs 1000 of fees as administrative charges.
- c) In case the candidate who has paid the fees after getting admission and gets his/her admission Cancelled after completion of admission on vacant seats, for any reason whatsoever, shall have to request in writing in person to the college or institution in which he/ she is granted admission but shall not be entitled to get refund of the fees paid by him for getting admission.
- d) In case of cancellation of admission at college or institution level on the request of the student, he/ she shall liable to pay the fees for the current semester and no college or institution shall demand fees for further semester(s).

#### **11) Documents to be uploaded with the application form:**

The candidate shall upload the self-attested copies of the following documents.

- a) Mark sheet : H.S.C. Examination (Standard 12<sup>th</sup> - 10+2 Pattern)\*
- b) Mark sheet : S.S.C Examination (Standard 10<sup>th</sup>)\*
- c) GUJCET/ NEET/JEE (Mains) Score Card
- d) School Leaving Certificate
- e) Transfer/Migration Certificate (If Applicable).
- f) Caste certificate for a candidate belonging to Scheduled Castes (SC), Scheduled Tribes (ST) and socially and Educationally Backward Classes (SEBC), Economically Weaker Sections (EWS) issued by the authority empowered by the State Government in this behalf.
- g) Valid Non-Creamy Layer (NCL) certificate of the family by the authority empowered by the Government in this behalf, if applicable.(Details related to validity will be as described above in point no. 4(b) & 4(e)
- h) Certificate of Physical Disability, issued and duly signed by the Surgeon/Medical authority, in case of a Physically Handicapped candidate.
- i) Certificate of Ex-Serviceman, duly issued by the Director, Sainik Welfare Board Gujarat State or by the District Sainik Welfare Officer, if applicable.
- j) A copy of certificate of In-Serviceman duly issued by the Commanding Officer of the respective unit in which they are serving, if applicable.
- k) Diploma Pharmacy 1<sup>st</sup> and 2<sup>nd</sup> year mark sheet if applicable.
- l) Admission form fees payment copy.\*

m) Any other certificate(s) needs to be submitted as the Admission Committee deems necessary.

\* All attempt(s) certificate(s) are required in case of more than one trial in S.S.C and/or H.S.C. Examination(s) and Diploma.

**12) Ineligibility for admission on production of false documents:** All the original documents are to be verified at the time of reporting to the allotted institute, if any document(s) is/are found incorrect/false, the admission will be cancelled. Also legal actions will be taken against the student/parents submitting false documents.

**13) Admission to Unaided Colleges / Institutions for Management seats:**

a) The Management Seats may be filled, by the management of the respective unaided colleges/ Institutions based on the inter-se merit of the applications received by institutions in accordance with the procedure as determined by the GTU Pharm D admission committee. The merit list shall be displayed on the website of the concerned college or institution.

b) Each college or institute shall have to conduct admission process in a fair, transparent and non-exploitative manner and no eligible candidate shall be denied issuing or accepting admission form.

c) For Management seat admission GTU registration is not required.

**14) Vacant Seats:** The admission shall be given in first and second round as well as management quota. If the seats are vacant even after that, then the Institute shall be given the right to fill such seats on the basis of inter-se-merit by inviting applications from the candidates registered on the admission portal as per rule 7 given above. Then the priority will be given to candidates who have given GUJCET exam for the corresponding year but not registered on the admission portal. Last priority will be given to candidates who have not registered on the admission portal and who have not given GUJCET examination.

**15) Penalty:** Breach of any of the provisions of these rules and any directions issued by the Gujarat Technological University or as the case may be, by any person, shall be liable for penalty.

**16) Interpretation:** In implementation of the provisions of these rules, if any difficulty or question arises as to the interpretation of any provision, the decision of the Gujarat Technological University shall remain final.
